**Herkimer County Legislature**  
**Fourth Quarter – Fourth Day**  
**Wednesday, December 14, 2011**  
**7:30 p.m.**

The Public Hearing on Introductory Local Law No. 2 for 2011 was called to order at 7:00 p.m. by Patrick E. Russell, Chairman of the Committee on Ways and Means. The clerk read the notice of the meeting. Mr. Russell asked if there was anyone wishing to speak on the local law. There were no appearances and the hearing was declared closed at 7:06 p.m.
