**The MISSION** the Herkimer County Office for the Aging is to provide a range of supportive services to older adults and their families. **OUR GOAL** is to assist older adults to remain in their homes for as long as possible. All those served will be treated



with respect and dignity. Those in greatest economic or social need are given priority.

**SERVICES PROVIDED**

**Nutrition Services and Meals on Wheels**

The Office provides **home delivered meals** to many areas of the County. We also offer **congregate dining** at five locations: Dolgeville, Little Falls, Herkimer, Ilion, & West Winfield. All home delivered meals are based on need. There are no income requirements for home delivered or congregate meals. A suggested donation of \$3.00 is requested for each meal.

In addition to meals, we offer **nutrition education and counseling**. A Registered Dietitian assists seniors and family members with diet changes and restrictions. Our monthly *Nutrition News* is on our website at [www.herkimercounty.org](http://www.herkimercounty.org).

**Farmer Market Coupons**

We distribute Farmer Market Coupons every summer. To receive the Coupons, Older adults must meet income guidelines. Coupons can be used at participating Farmers Markets to purchase locally grown vegetables & fruits.

**In-Home Services** Assisting older adults to remain in their homes includes helping with such things as bathing, housekeeping, and shopping. These programs serve older adults whose incomes are above the Medicaid levels.

Last year nearly 93,394 meals were served to 652 people.  
763 Farmer Market Coupons

10,814 hours of aide service was provided to clients.

**HEAP (Home Energy Assistance Program)** Provides low-income households with financial assistance for heating costs. We process HEAP applications for senior citizens.

During the 2021-2022 HEAP program, we processed 1,714 HEAP applications.

**Transportation** The Office provides transportation within Herkimer County and has wheelchair accessible vans available. Advance reservations are necessary because of the high demand for rides. Donations help to fill the gas tank and pay for the drivers and van repairs.

We provided 201 seniors with 5,742 rides

**NY Connects- Information, Referral & Public Information**

Needing to know where to get help is vitally important to older adults and their families. Getting information to people takes place in many ways: answering direct questions, press releases, local TV shows, distribution of information to senior clubs & clients, public speaking, newspaper advertising, pamphlet racks, our web site, and our newsletter, *Sharing the Spirit*, which we publish jointly with RSVP.

### Health Insurance Information, Counseling, & Assistance Program (HIICAP, pronounced “hi-cap”)

**HIICAP handled 1,911 requests for assistance**

This program assists older adults with health insurance issues on an individual basis. Catholic Charities operates this program for us.

### NY Connects

NY Connects is the phone number in Herkimer County to get information & assistance to make informed decisions about long term care for someone of any age, disabled children, adults & seniors. See our NY Connects website

**We provided Information & Assistance to 2,100 people.**

### Job Pool

The Job Pool provides names of people you can privately hire for many types of assistance. We provide names of people for hire; the OFA does not pay for the hire.

**232 seniors requested a Job Pool listing.**

### Legal Services

We have a contract with the Legal Aid Society to provide legal assistance to seniors. The majority of their assistance involves such things as wills, Power of Attorney, real property matters, credit issues, etc.

**87 seniors Received 203 hours of legal services**

### Recreation

The Office participates in the planning and hosting of the Herkimer County Senior Picnic and other activities and 350 people attended.

### Caregiver Assistance

This program provides support to people who are caring for someone who needs assistance with bathing, dressing, toileting, eating, mobility, transferring or personal hygiene. Caregivers are provided information about services, individual counseling and respite. Respite involves having an aide from a licensed agency come into the home to care for the person so the caregiver gets a break. Overnight (or longer) respite is available through a temporary placement at a nursing home.

Many books on the topic of care giving are available at the public libraries. Also, caregivers receive a monthly Caregivers Newsletter; this newsletter is also available at our website.

**1,520 hours of respite were provided.**  
**125 People received the Caregiver Newsletter.**

**Health Promotion–**

The Office for the Aging provides Evidenced Based Health promotion by providing Tai Chi classes throughout Herkimer County.

***2023 Budget Summary***

*The budget figures listed are based on the most recently completed grant program years. Some of these grants operate on the calendar year, others the state fiscal year of April 2022—March 2023 and still others are different from those! Since not all funding streams use the same budget year, amounts are estimates only. Revenues include federal or state funds as well as client donations received. The difference between expenditures and revenues is our County’s contribution, which was just over \$352,590 for 2023.*

This chart lists the names of budgetary funding streams, the source of the funding, and what it pays for.

Account	Name	Description
A-6772	IIB	Federal grant, part of the Older Americans Act. Mostly 90/10 match with some 75/25. <b>January-December</b>
		Covers transportation (operating costs of vans such as fuel, repairs, drivers, etc.), the Companion-Homemaker program, and much of the general office expenses. Due to constraints of billing in the mail room, most postage is included in this budget and then back-charged to other programs for reimbursement purposes.
A-6772A	IIID	Federal grant, part of the Older Americans Act; 90/10 match. <b>January - December program year.</b>
		This program is for Health Promotion and medication management. We subcontract to Catholic Charities as part of the HIICAP program.
A-6772D		Webb Transportation - 100% local funding; <b>January-December program year.</b>
		Provides assistance to the Community Transportation Service (CTS) in the Town of Webb. CTS is an all volunteer transportation service offering transportation for medical and other needs, including trips locally and to Utica, Syracuse, etc.
A-6772C	AAA	Transportation - 100% State Funds; <b>April-March funding year</b>
		This is funding stream is specifically for transportation services; we use it to offset fuel & repair costs for the vans. 100% funding from NYS.
A-6774	CI	Federal funds; part of the Older Americans Act. 90/10. <b>January - December program year.</b>
		This program is for congregate meals, where seniors get together at meal sites and eat. We have 5 meals sites funded under this stream, all sites are at senior housing facilities: Dolgeville, Little Falls, Herkimer, & Ilion (our 5th site is at West Winfield and is funded by CSE.) A "Meal Site Manager" is at each site. Meals are brought to sites in bulk form and Meals-on-Wheels are packaged up, then congregate diners are served.
A-6775	CSE	State funding; \$20,000 of 100% funding, balance is 75/25. CSE stands for "Community Services for the Elderly" <b>April to March program year</b>
		This program funds our congregate and Meals-on-Wheels. It also covers some general office expenses.
A-6775A	EISEP	State funding; \$20,000 of 100% funding, balance is 75/25. EISEP stands for Expanded In-home Services for the Elderly Program. <b>April - March program year.</b>
		EISEP provides case management and aide services for housekeeping & personal care to clients whose income is above the Medicaid level; there is a sliding fee scale based on clients income. We subcontract the case management to the Alternatives to Long Term Care Unit housed in DSS, and the aide service to At Home Care, Superior, and, for the Town of Webb, HASCA.
A-6776	CII	Federal funds, part of the Older Americans Act. 90-10 funding. <b>January-December program year.</b>
		Provides funding for Meals-on-Wheels.
A-6776A	SNAP	State funds; 100%; <b>April - March program year.</b>
		Provides funding for Meals-on-Wheels.
A-6777	HEAP	100% funds. The OFA is a subcontractor of DSS. <b>August - July program year.</b>
		As a subcontractor of DSS, we process HEAP applications for senior citizens and Code A SSI clients.

A-6780	HIICAP	Health Insurance Information, Counseling & Assistance Program. 100% funds; April-March funding yr.
		This program is subcontracted out to Catholic Charities. They provide assistance with health insurance issues.
A-6780B	MIPPA	Medicare Improvement Patient Protection Act-100% funding- September 30- September 29
		This program is used to provide assistance with health insurance issues. The program increase outreach to people with Medicare especially those with limited incomes.
A-6783	IIIE	Caregiver Program; federal funds, part of Older Americans Act; 75/25 January - December program year.
		Provides respite, information & assistance, training & support to caregivers. We contract with Superior, HASCA (Old Forge), RCIL (Old Forge day care) and Folts Homes for respite services.
A-6786A	BIP/NY Connects EE	State Funding- Formerly known as Balancing Incentive Program-April-March 31
		Provides funds to enhance the NY Connects network. These funds will be used to assist with creating a No Wrong Door system in New York State. NY Connects will provide Information and Assistance to individuals of all ages. NY Connects will assist Medicaid and Medicaid eligible individuals to obtain the necessary in home services so that they can remain in the community.
A-6786B	Alz. CSI	Alzheimer's Caregiver Support Program January - December program year.
		This is funding for respite services that is reimbursed by the Alzheimer's Association.
A-6786C	Unmet Needs	This funding allows additional funds to assist with the waiting lists for services. The funding is state funding with no local match. April to March 31
A-6774C	ARP-CMC6	The American Rescue Plan- Congregate Meals <span style="float: right;">Pro-</span> gram ends 9/30/2024
		This is a federal funding due to COVID-19 that will be used for Congregate Meals.
A-6776E	CARES-HDC5	The Coronavirus Aid, Relief, & Economic Security Act- Home Delivered Meals Program ends 9/30/2022
		This is a federal funding due to COVID-19 that will be used for Home Delivered Meals.
A-6776F	ARP-HDC6	The American Rescue Plan- Home Delivered Meals <span style="float: right;">Pro-</span> gram ends 9/30/2024
		This is a federal funding due to COVID-19 that will be used for Home Delivered Meals.
A-6772K	ARP-PHC6	The American Rescue Plan- Health Promotion <span style="float: right;">Pro-</span> gram ends 9/30/2024
		This is a federal funding due to COVID-19 that will be used to provide health promotion services.
A-6772J	ARP-SSC6	The American Rescue Plan- Supportive Services <span style="float: right;">Pro-</span> gram ends 9/30/2024
		This is a federal funding due to COVID-19 that will be used for Supportive Services such as transportation & Companion Homemaker.
